The Keith Family - Ambassadors Of The Year

I advocate on behalf of my husband, Ward, who has hemophilia A mild with an inhibitor. He was diagnosed at age 2, back in 1967, after being in the hospital with bleeding on the brain. He has grown up being in and out of the hospital for things like a bike accident, right-sided paralysis, and numerous hip surgeries. Due to these, he is not able to work and is on disability. I advocate because I want him to be able to have access to the proper medical care to ensure a good quality of life, not just for him, but for our daughter and our future grandkids (since our daughter Makayla is a carrier). I advocate because I want to educate people on what hemophilia is and the impact it can have on people, not just physically but also emotionally and mentally. Since Ward is not able to work he gets depressed. Thank God for the HTC. At his annual checkup, he saw the psychologist and got help for his depression. I advocate because I want to see the HTC continue to get the funding needed to stay open to serve our community. My husband is a wonderful man and having his hemophilia managed in a way that promotes his best life is why I advocate.

Being a caregiver for a daughter with a bleeding disorder can be a challenge. Outside of the everyday bleeding challenges it often feels as though we have to explain ourselves and advocate for ourselves frequently. Anything from meeting a new doctor, to setting up a 504 or applying for health insurance can be met with pushback. A lot people have not heard of VWD or still believe that girls cannot bleed—even with a diagnosis. We live everyday encouraging our daughter to have strength and to advocate for herself. We've worked very hard to ensure that she receives proper treatment and care. We know that she can continue to advocate for herself, but at the same time we hope that she won't need to.







PACE REPORT

Public Outreach

In 2021, we hosted a Bleeding Disorder Awareness Month campaign at Falls Park in Greenville including lighting the Liberty Bridge red. We held a kickoff for the Red Tie Campaign with city and county proclamations recognizing March as national Bleeding Disorders Awareness Month. We held a virtual World Hemophilia Day event, hosted a STEP for Bleeding Disorders fundraiser (that was open to the public), and held our annual Par for the Clot Charity Golf Tournament.



Community Connections

In 2021, we continued to develop our support groups including our M.EN.S., C.A.R.E. (women's), and Y.ES. (children's and young families') support groups, as well as continued teen programming. We held myriad meetings, programs, and activities for each of these groups throughout the year. We also continued our Virtual Innovations Program (VIP), utilizing iPads to keep members connected and informed about ongoing BDASC activities.





Advocacy

In 2021, five BDASC members participated in NHF's Annual Washington Days for virtual meetings with the offices of both South Carolina U.S. Senators and four of the seven members of the House of Representatives. We held completely virtual state Advocacy Days with 22 Zoom meetings. We advanced H3956 to create a Rare Disease Advisory Council in the state, passing it out of the House of Representatives and pushed to have it created via proviso at the end of the session.




Education


