2) Quick Reminder of BDASC Industry Standard Policies:

*Do work with in partnership with Sue wherever possible with the BDASC Chapter.

*Do try to be inclusive of all the patients when having an event wherever possible. Discuss with Sue what your needs are for the event, and you can produce a good plan. If you are interested in partnering on an event, just ask.

*Chapter is struggling to meet the financial needs of the community and administrative expenses. Sue will be hiring someone full time.

*Samantha handles Engagement like registrations for Events, Graphic and Social Media Needs of the Chapter. Erin helps to host the Events and Fundraisers.

**Sue does need sponsors for events, advertising, etc. to meet the financial needs of the Chapter. Chapter is working to keep members engaged with the right balance of frequency of events and education.

*Sue is investigating the fall event location currently with the goal being a Camp type of event.

3) BDASC Sponsorships and Opportunities for 2025:

EVENTS: moving forward the National Chapters will not be providing as many speakers from here on out so we will have to look for speakers from Industry, HTCs and others to support the need of the Chapter.

*Ask Sue about Branded/ Unbranded programs but keep in mind the number one goal is education. The process from the Chapter as far as products is to refer patients back to their

Physicians for treatment education so that patients are partnering with their HTC providers for treatment decisions.

*Sue can host small events now in the BDASC Chapter Office. Smaller programs and events would fit in the office comfortably.

A Code of Laws and the Bill language is in need of realignment to be beneficial to patients. Sue will be meeting with BCBS and the Senate to move the bill forward hopefully in the Senate. The house bill has over 75 sponsors. Sue has concerns over Medicaid and it is very important to protect Medicaid treatment therapies the physicians prescribe for our patients in the community.
